**BACKGROUND**

- E. The Athlete has agreed to accept the services and support offered by SWAS as outlined within the terms and conditions of the Athlete Agreement.

It is agreed between the parties as follows:

## **1 GRANT**

SWAS has agreed at the request of the Athlete to grant to the Athlete the services and support described in the Schedule ("Services and Support") to enable the Athlete to participate in the Program.

## **2 TERM**

This Agreement shall commence on the date of signing and shall, subject to the other provisions of this Agreement, terminate on the \_\_\_ day of \_\_\_\_\_ 2011 ("**the Term**").

## **3 TERMS AND CONDITIONS**

The SWAS Athlete Agreement Terms and Conditions are incorporated in and shall form part of this Athlete Agreement to the extent that they are not inconsistent with or varied by the terms of this Athlete Agreement.

## **4 BUDGET (WHERE APPLICABLE)**

Prior to any services or support being made available by SWAS to the Athlete the Athlete shall provide SWAS with an accurate budget of how the Athlete proposes to utilise any funds made directly available to the Athlete under this Athlete Agreement for the purpose of fulfilling the Program.

## **5 FEES FOR SERVICES**

The services provided to the Athlete by SWAS described in the Schedule (if any) shall be made available for the fee mentioned in the Schedule which shall be payable prior to delivery of the services or in such other manner as may be mutually agreed.

## **6 SPONSORS**

The Athlete agrees to protect the name, reputation, image, products or services of SWAS or SWAS' sponsors mentioned in the Schedule (and any other sponsors appointed by SWAS from time to time) in the manner described in the Athlete Agreement Terms and Conditions

## **7 POLICIES AND GENERAL INFORMATION**

By signing this Athlete Agreement the Athlete acknowledges receipt of the SWAS Athlete Agreement Terms and Conditions and the SWAS Anti- Doping Policy.
